Conditions for Consignment

1. We accept consignments as follows: Monday thru Friday 10:00 a.m. - 4:00 p.m.
Spring and Summer Items - February thru July
Fall and Winter Items - August thru January
2. Items, to be accepted, must meet the following standards:
 - A. **CLOTHING MUST BE FRESHLY LAUNDERED & PRESSED, AND ON HANGERS.
WRINKLES DO NOT SELL.**
 - B. **STYLE MUST BE CURRENT WITH ACCEPTABLE FABRICS.**
 - C. **ALL ITEMS MUST BE FREE OF STAINS AND ODORS (MOTHBALLS, PERFUMES,
CIGARETTE SMOKE, PET HAIR, *etc.*)**
 - D. **ALL HOUSEHOLD AND OTHER GOODS MUST BE CLEAN AND IN GOOD CONDITION.**
 - E. **CLOTHING SHOULD BE NO MORE THAN 3 YEARS OLD.**
3. Please do not take offense if we find it necessary to say no to some of your items. We rely on past experiences of what sells and space considerations to make our selections.
4. Pricing an item (both initially, discounts, and promotions) is at the discretion of ***etc.***
5. The Consignor will receive 40 percent of the sale price after an item is sold. Furniture, and some specialty items will be handled on a 50-50 basis.
6. **Consignors may collect for items sold by coming to *etc.* during working hours.**
7. Length of time for consignments is 60 days. At the end of 45 days the consignor may come to the shop, locate and retrieve their unsold items. A \$10 fee is charged for items picked up before 45 days. Unclaimed items become the property of ***etc.*** after the 60 day period. The sixty day period is not applicable to fine jewelry or furniture. All such items will also be discounted by store personnel, not through our regular discount system.
8. The consignor will pay an initial registration fee of five dollars (\$5.00) for registering an unlimited number of items. This fee is renewable on your anniversary date.
9. ***etc.*** will use care but is not responsible for consigned items in case of theft, fire, or damage. Consignments left at ***etc.*** are at the risk of the consignor.
